This form is to be reviewed and signed by parents who are residing overseas and have appointed a custodian to care for their child during their child's studies in the Louis Riel School Division (LRSD) that are not in the LRSD Homestay Program.

LRSD and Immigration, Refugees and Citizenship Canada (IRCC) require parents who are not residing with their child during their studies in Canada to appoint a custodian. Notarized copies of page 1 & 2 of the Custodianship Declaration form (IMM 5646) must be submitted to the International Student Program (ISP) prior to the student arriving in Canada or when changing custodians (*please refer to IRCC for a copy of this form - <http://www.cic.gc.ca/english/pdf/pub/custodian-parent.pdf>*). A custodian must be appointed to ensure that there is a local person directly responsible for the child's supervision and care during their stay in Canada.

The legal custodian of the student must:

- Keep parents well informed of their child's academic progress, health and wellbeing.
- contact the school in the event of illness, medical appointments, tardiness, etc.
- be responsible for sharing information with the student's biological parent, including academic progress, health, wellbeing, academic progress reports and academic performance.
- inform LRSD of any updates regarding the student's information (address, medical, etc.)

Parents who reside overseas play an important role in ensuring their child is being properly cared for and supervised during their studies in LRSD. Please ensure that:

- you have chosen a suitable custodian, who is 25 years of age or older and is a Canadian Citizen or Permanent Resident.
- your child is living in a suitable home with a responsible adult of 25 years of age or older.
- you regularly contact your child and their appointed custodian to check that he/she is being properly supervised and is thriving within his/her learning and home environment.
- you will notify the International Student Program in writing of any change in the appointed custodian, address or contact information of your child.
- if you have any concerns about your child's wellbeing or academic progress, immediately contact the custodian to resolve the issue. In the event that you are not satisfied with the home or custodian please make alternative arrangements and inform the International Student Program immediately. The minor student must be in the care of a suitable custodian at all times during their stay in LRSD.
- you are required to provide alternative contact and phone number in the event that LRSD is not able to reach you, in particular in the event of an emergency.

LRSD Independent Custodian's Responsibility

The LRSD relies on parents and custodians to notify the ISP of any issue or problem their child may be experiencing. Without this important information, LRSD is limited in the support that can be provided to assist the child.

As an overseas parent who has appointed a custodian for my child, I understand that the custodian is responsible to properly supervise and care for my child as well as keep me and the International Student Program informed of any issues or problems my child may experience. I also understand that I will continue to play an important role in ensuring my child's wellbeing during his/her studies in LRSD. In the event that my son/daughter turns 18 during his/her studies in LRSD, I understand that the above rules still apply.
